

While GMPC's vision for ministry includes all these many facets, we remain Reformed, always being reformed according to the word of God and the call of the Spirit-making our community into a living sanctuary in which all can know, experience and give thanks for God's love. In order to accomplish our mission, we seek a pastor who will preach with compassion, hope and love from the pulpit. The pastor should demonstrate these traits daily as he/she interacts with individuals.

# How do you feel called to reach out to address the emerging needs of your community or constituency?

The congregation has had a significant impact on the life of Clinton and Sampson County since 1831. We have been conscious of our worship, congregational life and outreach ministry. We feel our fundamental identity and purpose comes in our faith in the Triune God, the proclamation of the Gospel, our life in Christ, and the fellowship of the church. The church's leadership believes that GMPC should be known in the following ways:

A congregation where intergenerational activities are given a strong focus

A place where congregational communication is key to transparency

A congregation which is inclusive, inviting, and welcoming to all

A congregation trained in pastoral care, education and leadership as an ongoing practice

A congregation which desires to increase our caring for one another.

A congregation who desires to meet needs through time, efforts, and money

A congregation who supports world-wide Christianity through missions and missionaries

GMPC will continue its strong participation in the emerging needs of the immediate community as well as the world at large through its active participation in mission activities.

## How will this position help you to reach your vision and mission goals?

The pastor of Graves Memorial Presbyterian Church must possess strong leadership characteristics in order for the church to accomplish its vision and goals. As leader, the minister must be adaptive, flexible, and prepared to lead the modern-era church into a postmodern ministry. This individual must possess strong interpersonal skills, emotional and spiritual fitness, and the ability to communicate a vision, lead change, empower others for leading, and serve in the midst of ambiguity.

We are an older congregation seeking revitalization with interest in intergenerational activities. Our pastor will need a heart for all generations and a creative spirit. We love our congregation and desire someone who has a passion for pastoral visitation. We believe church is where we come to be nourished and cared for, where our pastor is a leader and role model. We hold tight to our history but want to seek new opportunities to share Christ's light in surrounding neighborhoods with possibilities of after school tutoring and an afternoon of children's activities. Our struggles have been real with re-energizing our children and youth programs in the aftermath of Covid. With imagination and congregational teamwork we can attain our goals.

Provide a description of the characteristics needed by the person who is open to being called to this congregation and or organization.

Of primary importance is that the new pastor have a clear sense of being called by God to our congregation. He/She must be approachable and be one who is skilled in reaching consensus, resolving conflict, and valuing differing opinions of others. The pastor must have demonstrated leadership skills and management of a small church with limited support staff. The pastor should have the capability of leading and teaching others in spiritual growth and understanding of the scriptures. Critical to the position is one who can communicate to people of all ages in both written and verbal means.

## What specific tasks, assignments, and program areas will this person have responsibility?

Central to his/her duties is the preaching and teaching of the Word. As pastor, the person will be head of staff. Reporting directly to the GMPC personnel committee the pastor serves as Moderator of the session. The pastor will oversee all aspects of the church. The pastor will be expected to make visits to individuals in times of need; for example, sicknesses, deaths, counseling needs, and visits to get to know members better. The pastor will coordinate all programs of the church such as Christian Education, youth activities, senior adult activities, etc. The pastor is expected to take an active role in the Presbytery of Coastal Carolina. There is a local ministerial association of which the pastor should participate in. On many occasions, the pastor is expected to participate in other community sponsored activities.
